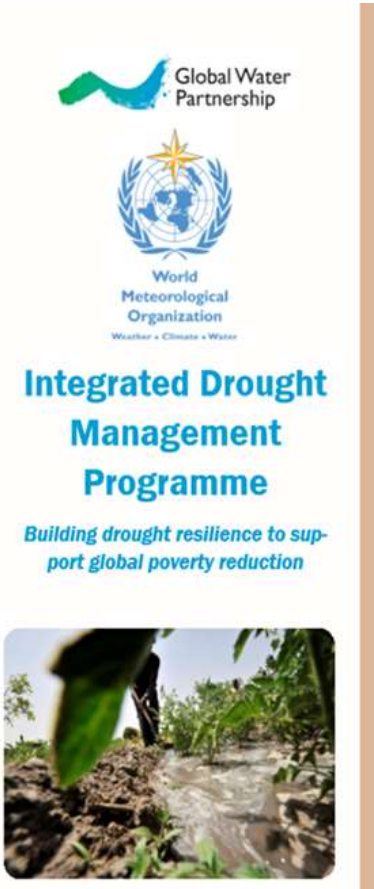

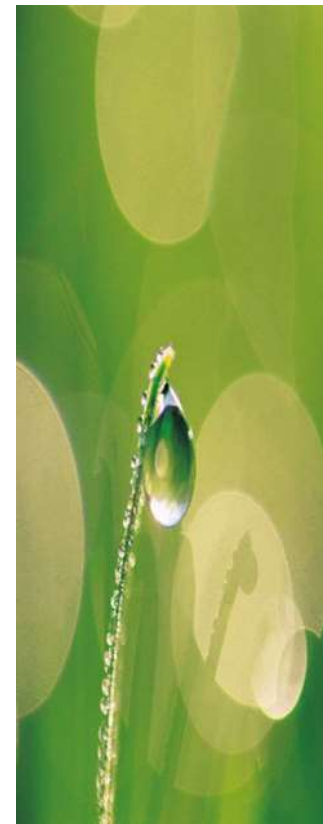

Goal 1 : Catalyze change



➤ ***WP1: Drought negative effects are managed in West Africa through the regional initiatives and cooperation.***

- Regional situation analysis
- Drafting of final IDMP WAF document
- IDMP WAF inception workshop
- Review in details of drought's initiatives/institutions

➤ ***WP2 : Improvment of drought management through national and regional plan/strategies reviewed***

- Assessment of existing national plan (including in the review)
- Preliminary exchanges with ECOWAS to put in place a regional guidelines on DM

Goal 1 : Catalyze change



➤ ***WP3 : : No regret investment are included in some institutions budgets mechanisms***

- Planned for Q3 and Q4

➤ ***WP4: New sources of project financing are leveraged by concerned governments***

➤ ***WP5 : News innovates solutions found for Drought Management in the focus sub area (water resources, agriculture, desertification)***

- Development of ToR: CWP's and national partners will propose joint demonstration projects

- Consultations were conducted with CAPNET on their DM training module
- Tool for need assessment was elaborated

- Sharing through media any IDMP action (articles on GWP website and local newspaper, TV; IDMP global programme sheet;)

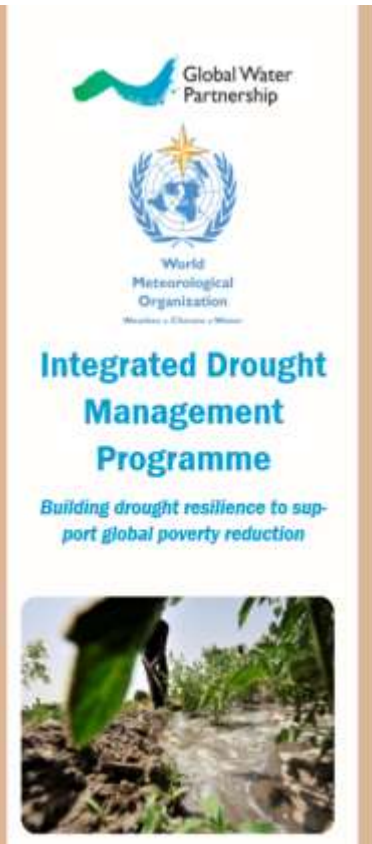

Goal 3: Strengthen Partnerships

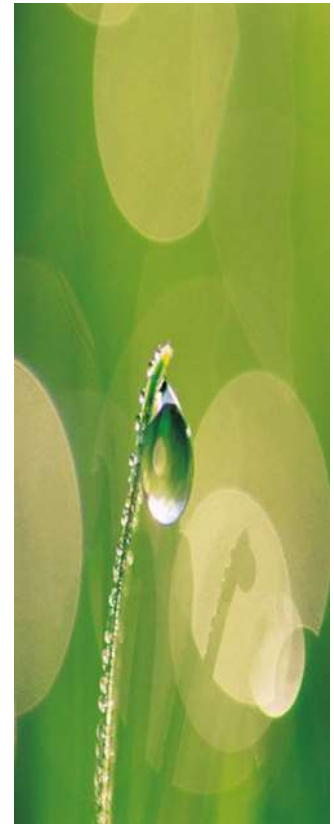


➤ ***WP8 : Regional/ countries level partnerships' competencies enhanced***

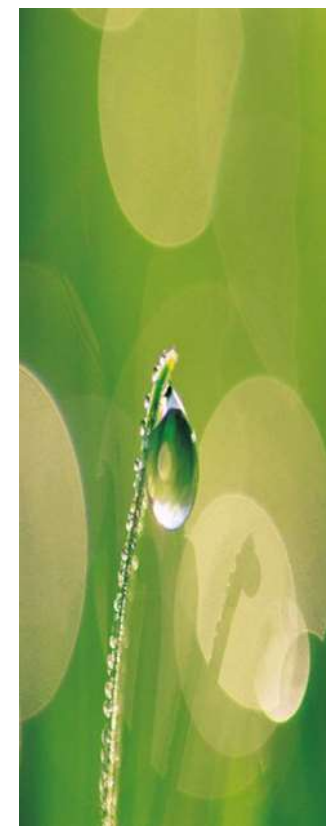
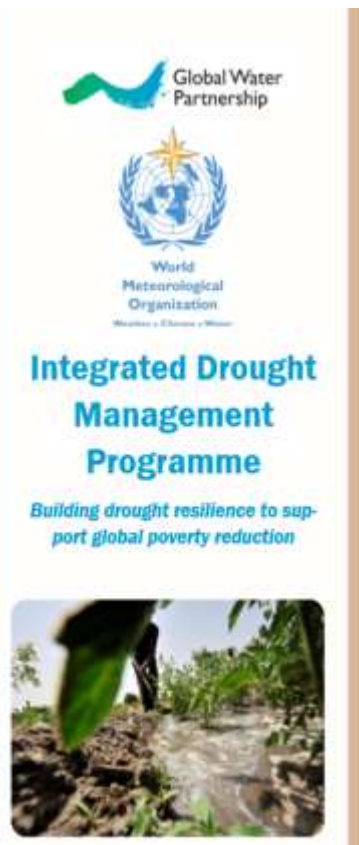
- Lack of strategic institutions for “*National and Regional Policies and Strategies*” activities: No institution is specialized on all drought sub areas, IDMPWAF will work then from the top with ECOWAS and CILSS but this process take time.
- GWP is seeing as a donor at national and regional level: The strategy is to involve partners by their contribution in some activities as demonstration projects, training and platforms actions.

Challenges

- Knowledge and Capacity Development Learning outcomes will not be used to improve drought management in the region

To conclude

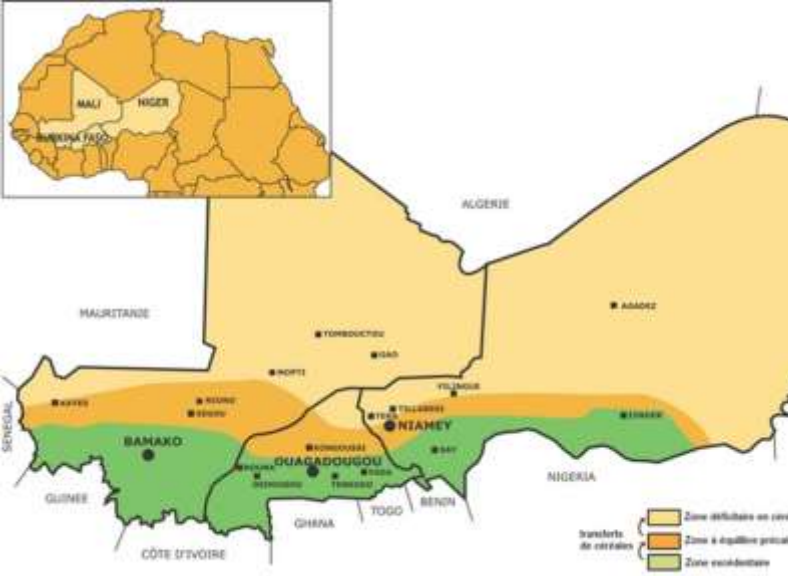
West Africa is heavily affected by drought. Several actors are working separately to resolve problems but challenges remain.
